El Laboratorio Veterinario Central (LAVECEN), Departamento de Diagnostico, de la Dirección General de Ganadería, Ministerio de Agricultura gracias al apoyo de OIRSA cuenta con la acreditación de sus pruebas de ensayos en salud animal. Además, República Dominicana cuenta con laboratorios acreditados como son: Instituto de Innovación en Biotecnología e Industria (IIBI), Laboratorios Agroempresarial Dominicana (pruebas microbiológicas).

El Laboratorio de la Dirección General de Aduanas tiene las capacidades para realizar un grupo considerable de pruebas de ensayos en ámbito de microbiología, plaquicidas, combustibles, entre otros.

USDA/TraSa ha estado apoyando al Laboratorio de Inocuidad de Alimentos y Análisis Industrial (LIAAI) de la universidad ISA y al Laboratorio de la Junta Agroempresarial Dominicana (JAD) con la acreditación de métodos para la determinación de residuos de plaguicidas. Con el LIAAI se han realizado entrenamientos en el uso de la cromatografía liquida de alta resolución (HPLC) y en la validación de protocolos. Como también la certificación de la ISO/IEC 17025:2017.

Se requiere continuar con la asistenta para dar sostenibilidad a la red de laboratorios en los siguientes ámbitos:

- 1. Apoyo para la acreditación y certificación de más laboratorios de pruebas a nivel nacional.
- 2. Apoyo para la implementación de metodologías y cumplimiento para las pruebas y calibración de equipos.
- 3. Asesoría para la implementación de sistemas de gestión basado en los requisitos de las normas ISO/IEC 17025, versión vigente y políticas internacionales aplicables a los laboratorios.
- 4. Capacitación del personal encargado de los laboratorios en funcionamiento.

El Banco Interamericano de Desarrollo (BID) elaboró el Manual para el manejo de carga perecedera con cadena de frío. USDA, a través del Programa Exporta candad, financió una campaña de comunicación para dar a conocer este manual de perecederos.

USDA a través del Proyecto TraSa, suministró asistencia técnica a la Oficina de Tratados Comerciales Agrícolas (OTCA) del Ministerio de Agricultura para reforzar las capacidades técnicas de los organismos público-privado que intervienen y son partes del sistema sanitario nacional y calidad.

En el marco de la mesa de perecederos, la Oficina de Tratados Comerciales Agrícolas asumió la coordinación con las agendas actuantes en frontera de la elaboración de los protocolos de manejo de la carga perecedera con cadena de frío basados en el Manual de Perecederos, así como la impresión de los manuales y las guías pequeñas (por grupo de productos) desarrolladas y la correspondiente distribución del material de apoyo audiovisual (CD y enlace web).

Se coordinó la entrega de los manuales de perecederos y las guías por grupo de productos, y distribución del material audiovisual a los distintos puntos sanitarlos nacional, en cumplimiento con este Articulo 7.9 y las disposiciones del Decreto 346-19 sobre cadena de frio en cada punto cuarentenario a través de las agencias sanitarias (Ministerio de Agricultura, Ministerio de Salud).

El Proyecto UDSA/TraSa ha respaldado el desarrollo del marco regulatorio nacional para la cadena de frío, ofreciendo capacitación a representantes públicos y privados sobre la gestión de carga perecedera. Además, ha realizado significativas donaciones de equipos y demostraciones tecnológicas para apoyar a las MIPYMES del sector.
