El objetivo de la iniciativa fue la implementación del AFC de la OMC, modernizando la normativa relacionada con la gestión sanitaria y así, mejorar la competitividad del comercio exterior peruano.

Los participantes de la iniciativa fueron: MINCETUR en calidad de entidad líder de la iniciativa en colaboración con DIGESA, SENASA, SANIPES, APN, SUNAT, RREE, ADEX, CCL, SNI y COMEX. Asimismo, se contó con el soporte técnico del Banco Mundial y el Instituto Interamericano de Cooperación para la Agricultura.

En cada componente se desarrolló: un diagnóstico, análisis comparativo (benchmarking) con las mejores prácticas internacionales, análisis de brechas, desarrollo de sistemas o modelos para cubrir esas brechas y la ejecución de pilotos, así como la capacitación de los agentes interesados.

El Componente 5 de la iniciativa es el que corresponde a "Notificaciones de controles o inspecciones reforzados". Su objetivo es establecer un sistema nacional de gestión de notificaciones y alertas sanitarias. Al respecto, a partir de un diagnóstico técnico nacional y un análisis de brechas con las mejores prácticas internacionales, se elaboró la propuesta de modelo nacional de gestión de notificaciones. Este modelo incluyó la propuesta normativa que crea el sistema y lo hace operativo y se necesita que las autoridades emitan dicha norma: Decreto Supremo que modifica el Reglamento de la Ley de inocuidad de los alimentos.

Actualmente, se está desarrollando un módulo de gestión de notificaciones en la Ventanilla Única de Comercio Exterior (VUCE).

Se espera recibir cooperación para la gestión de la aprobación de la norma y para su implementación.

El Componente 3 de la iniciativa es el que corresponde a "Procedimientos de prueba". Su objetivo es establecer procedimientos y operaciones armonizados para que las autoridades puedan realizar una segunda prueba a productos (que apliquen) que hayan tenido una "no conformidad" en el análisis de certificación sanitaria. A partir del diagnóstico y recursos disponibles, se generaron propuestas generales de normas, así como un procedimiento general: Decreto Supremo que modifica el Reglamento de la Ley de inocuidad de los alimentos, y Decreto Supremo que aprueba el Reglamento del Procedimiento para la Segunda Prueba en el Control de Alimentos y la Designación de Organismos evaluadores de la Conformidad en Inspección y Ensayo para la Segunda Prueba y crea el Proceso de Inspección Única Sanitaria de Alimentos en Frontera.

No se pudieron proponer normas específicas, dado que, para lograrlo, se necesitaba una evaluación de riesgo profunda por autoridad y esta implicaba mayor cantidad de tiempo y presupuesto.

Asimismo, se realizó la sensibilización del sector público y del privado en la jornada internacional de la iniciativa (noviembre 2022).

Se espera recibir cooperación para la gestión de la aprobación de las normas y para su implementación.
