Trinidad and Tobago has developed the Trade and Business Information Portal (TBIP), which hosts the Trade Facilitation Enquiry Point (TFEP). On the TBIP, which is accessible via [www.tbizlink.gov.tt](http://www.tbizlink.gov.tt), users can submit queries on trade-related issues pertaining to the WTO TFA, which are then routed to the relevant authorities for responses. Currently, the Caribbean Development Bank is funding a project to formalize the process for routing enquiries, inclusive of timelines for responses, and responsibilities for the various Ministries and agencies.
