

The Trade Facilitation Agreement (TFA) entered into force on 22 February 2017 when the WTO obtained the two-thirds acceptance from its 164 Members.












#### Mapping of technical assistance arrangements, as notified by beneficiary Members







Timeline of extension requests received, by measure


No. of extension requests received by measure













