Republic of Moldova accession to the EU

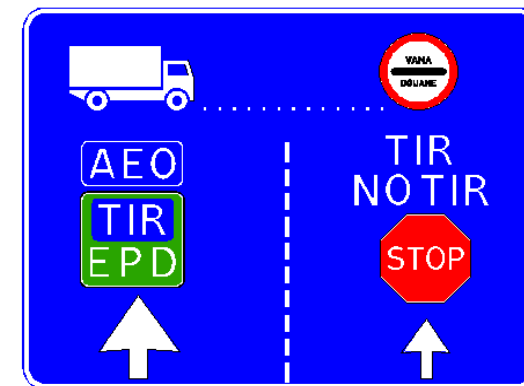
- **March 2022** – RM applied for EU membership
- **June 2022** – RM granted EU candidate status
- **December 2023** – decision on opening accession negotiations
- **25 June 2024** – accession negotiations officially opened





Republic of Moldova accession to the EU customs progress

- **November 2023** - AEO Mutual recognition RM-UE
- **January 2024** - New Customs Code
- **June 2024**- System (SEED+) - Project of automatic exchange of customs information between the Republic of Moldova, Romania and Ukraine

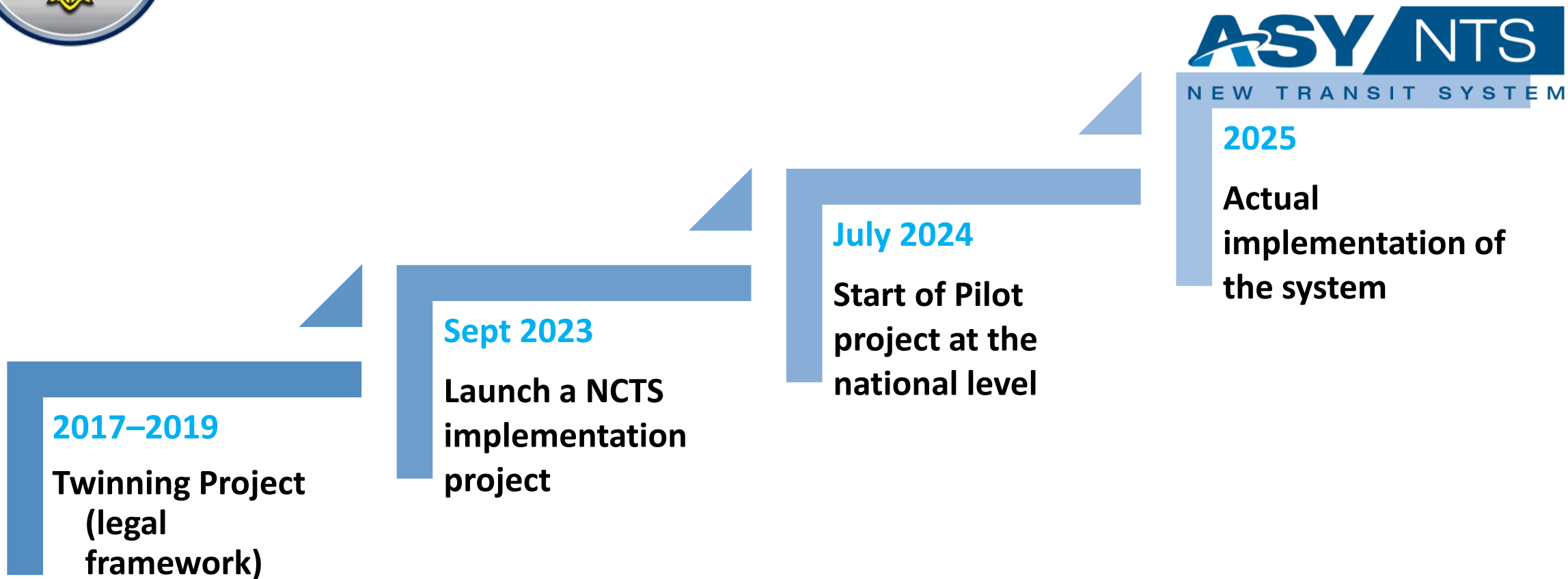
NCTS PROJECT implementation

NCTS PROJECT SPECIFIC OBJECTIVES

- ▶ Develop a National Transit System (NCTS-NTS) aligned with the NCTS-P5 specifications and national requirements, including country specific deviations
 - ▶ Implement the NCTS-NTS capabilities into the operational CSRM ASYCUDA environment, ensuring full interoperability with existing and prospective ASYCUDAWorld system
 - ▶ Capacity building, end-users training, both Customs officers and business community
 - ▶ Further strengthen the trade facilitation by simplifying the trading environment in terms of customs procedures and documentation, while improving the customs supervision and monitoring
- ▶ *Project governed by a Contribution Agreement between European Union and UNCTAD for the implementation of the action "Development and Implementation of the National Transit System (NTS) of the Customs Service of the Republic of Moldova, compatible with NCTS Phase 5 (NTS-NCTS)"*

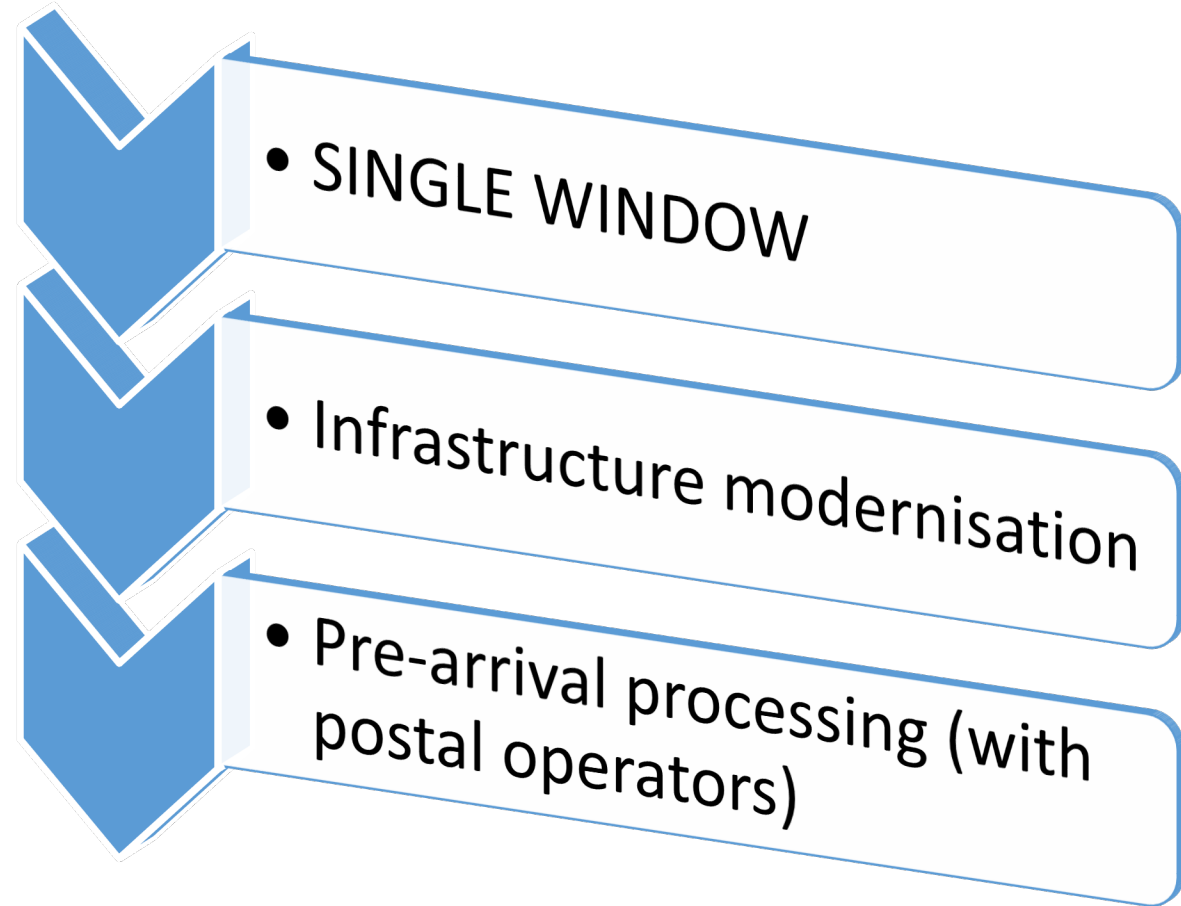
