





## MAIN ACTIVITES

- Regional and national virtual workshop with international experts and members of WCO, UN-OCHA and WFP.
- Compilation of international instruments and good practices in a regional toolkit.
- National assessments and gap analysis on national legal frameworks, conventions adopted and operational procedures to import critical goods during emergencies.
- Recommendations for actions and adjustments to develop and-or strengthen contingency plans and standardized operational procedures for Bahamas, Chile, Ecuador and Honduras customs.
- Planning, design and implementation of virtual simulation exercises to validate contingency plans and standardized operational procedures.
- Development of a virtual course to further strengthen capacities in the region.

#### HONDURAS

- From 2021 to 2023 a **Contingency Plan and the Standardized Operational Procedures (SOP)** were drafted by Honduras Customs in coordination with other government agencies (Permanent Commission for Contingencies-COPECO, Secretary of Foreing Affairs and International Cooperation, Agro Food Safety-SENASA, Health Agency-ARSA, Secretary of Finance SEFIN) with the support of the IDB.
- The virtual **simulation exercise** a hurricane to test the Contingency Plan and SOP was conducted on June 29 2023, with the participation of the Red Cross from Honduras and World Food Program from UN as evaluators.
- As a result of the simulation exercise the following **recommendations** were identified:
  - To introduce some adjustments to the Contingency Plan and SOP (ongoing) for final internal approval by Customs.
  - A recommendation for COPECO to finish the review of the operational regulation for Honduras and its submission for approval of Congress.
  - The need for further training for customs and other agencies about the SOP and its application.
  - A presentation of the SOPs to the humanitarian community is scheduled for Oct 2023.

#### CHILE

- From 2021 to 2023 a **Contingency Plan and the Standardized Operational Procedures (SOP)** were drafted by Chilean Customs in coordination with other government agencies (National Service of Prevention and Response for Disasters (SENAPRED), Ministry of Foreign Affairs, Ministry of Interior, Phyto zoo sanitary Agency, Institute of Public Health and other agencies such as the Police, Carabineros, Ministry of Public Works, Ministry of Finance\_Single Window Agency \_SICEX, Ministry of Fisheries and Ministry of Transport, amongs others) with the support of the IDB.
- The **virtual simulation exercise** an earthquake to test the Contingency Plan and SOP was conducted on August 25 2023.
- As a result of the simulation exercise the following **recommendations** were identified:
  - To make minor adjustments to the SOP (ongoing) for final formal approval by Customs and other agencies.
  - To strengthen interagency coordination by the creation of a committee or working group for the coordination of international humanitarian aid, including humanitarian organizations agencies.
  - The need for further training and dissemination for Customs and other agencies about the SOP and its application.

#### LESSONS LEARNED

- **High exposure**. Since 2000, 3 of every 10 inhabitants of the LAC region have suffered from a hurricane, an earthquake, drought, landslides or volcanoes.
- **Room for improvement**. Despite all the preparedness work, there is still a lot of work to do for Customs agencies and border agencies to develop and strengthen their contingency plans and standardized operational procedures to facilitate the entry of critical goods.
- Coordination is key. It is always important and necessary to establish a coordinated border management approach, specially during a disaster.
- Update rules and processes. Efforts are needed to update national frameworks and to comply and adopt international conventions. The involvement of other government agencies is necessary. Customs and border agencies need to continue updating and validating their contingency plans and standardized operational procedures to keep them relevant. Simulations and table top exercises should be conducted regularly.
- **Regional approaches**. It is also important to generate harmonized regional instruments in order to facilitate the entry of goods in cases of emergencies and disasters.
- **Dissemination of contingency plans**. These procedures should be communicated to the international humanitarian assistant community including training -, and to the private sector since they are also critical actors during a disaster and emergency.
