





The evolving role of trade facilitation policies in reducing trade costs



Impacts from a 10% improvement in the TFIs, by areas (%)



A 10% improvement in the trade facilitation policy measures that matter for *going paperless* can deliver an increase of up to 18% in global goods exports



And enable new trade relationships




