- Convertir el CENTREX en la Ventanilla Única de Comercio Exterior de Honduras (VUCEH) con la incorporación de los diferentes trámites y procedimientos de comercio exterior en el Sistema Electrónico de Comercio Exterior de Honduras (SECEH); facilitando el flujo comercial y contribuyendo en la toma de decisiones en materia de políticas públicas.
- Desarrollar un plan de trabajo de pruebas piloto y capacitaciones a todos los usuarios sobre los cambios, procesos y trámites contemplados en esta consultoría para el desarrollo e implementación de la VUCEH.
