1. Funding for infrastructure development, accreditation formalities, procurement of testing & metrology and other laboratory related equipment and consumables;
2. Support to build up capacity for testing, inspection and metrology, equipment and training in metrology. Reviewing the legal framework and procedures (SOPs) for analysis of various parameters;
3. Technical support to help develop and build capacity of Customs officers and staff of other relevant agencies;
4. Technical Assistance and Capacity Building to facilitate notification for enhanced controls or inspections.

**Progress reported**

1. The Department of Agriculture received technical assistance under the support towards operationalization of the SADC Regional Agricultural Policy (STOSAR) project funded by the EU/FAO in 2020-2022 and procured inspection kits for the personnel of the Department of Agriculture (DOA) used for inspection at the border for assessment and clearance of goods. In addition, the FAO/IPPC, through its technical cooperation project, conducted a Phytosanitary Capacity Evaluation (PCE) in 2023 to evaluate the National Plant Protection Organisation (NPPO) Phytosanitary capabilities, which is the border control, and support division.
2. The Public Health Authority (PHA) received technical assistance under the previous EU-ESA iEPA-Regional Integration Support Programme 3 (RISP3) for the training of laboratory personnel through an overseas mission in Scotland. Secondly, they received technical support from a consultant funded under the project for drafting of the Food Act (Import & Export) Regulations 2024 that started in April 2019 until 2021. Additionally, assistance with drafting the Standardized Operating Procedures (SOP) for inspection of food establishments at the border and internal market was also obtained.

**Progress reported**

1. The Seychelles Bureau of Standards (SBS) under the Southern African Development Community (SADC) – Trade Related Facility (TRF) received technical and financial support from the SADC TRF and the EU to procure and commission testing equipment and personnel training to enhance capacity for testing and certification of products. Under the SADC TRF, these consisted of:

- 1) An analytic balance
- 2) Dissolved oxygen meter
- 3) Turbidity meter
- 4) Laboratory refrigerator
- 5) Chest freezer, incubators and uninterruptible power supply.
- 6) Biological oxygen demand.

2. Furthermore, the personnel at SBS were recipients of capacity-building training for legionella and listeria to enhance the testing and certification of products.

3. Under the European Union (EU) 11th European Development Fund, the Seychelles Bureau of Standards (SBS) received financial support to procure a FID Detector and Injector for the SCION Gas Chromatograph for testing cinnamon oil, an ion chromatograph and soil gauge. In addition, the Excise unit of the Customs Division, under the aegis of the Seychelles Revenue Commission (SRC), received equipment for testing of alcohol strength parameters.

#### Progress reported

1. The Seychelles Customs Division, under the aegis of the Seychelles Revenue Commission (SRC), received financial and technical support from SADC for funding and support for the implementation of the World Customs Organisation (WCO) - Cargo Targeting System (CTS). The technical support allowed the resolution of interoperability issues encountered due to manual operation.
2. The Customs Division, in collaboration with the United Nations Organisation on Drugs and Crime (UNODC), is to provide technical support for the enhancement of the ASYCUDA World System for interoperability with UNODC's border security and maritime surveillance system. A UNODC delegation is expected to visit Seychelles in 1st quarter of 2025 to set up the Port Control Unit. The office space for UNODC is ready, awaiting equipment from UNODC. In addition, Customs officers have obtained theoretical training, and the practical training is scheduled for the 1st quarter of 2025.
3. Technical support to the Seychelles Customs Division for installation of the new version of the CTS free of charge has been provided by WCO and the provision of technical support is ongoing.

#### Progress reported

1. The Seychelles Revenue Commission, under its laws and Statutory Instrument (S.I) 42 of 2014, Chapter 13 Regulations 81(1) and 82 stipulates the processes and procedures for disposal of rejected goods within the mandate of the Customs Division of Seychelles as relating to customs and border security. Under the Animal Plant Biosecurity Act 2014, provisions exist which stipulate how rejected goods are dealt with.
2. Under the Food Act, 2014, provisions exist for rejected consignment of goods to be relabelled or reconditioned or export or disposed of by the importer subjected to the necessary provisions of the Act. Any contravention of the provisions may allow the Competent Authority to dispose of the rejected goods and applicable fines are applied to the individual importers.
3. The Department of Agriculture received technical and financial assistance for the procurement of an incinerator under the 10th European Development Fund (EDF), which has been refurbished through budgetary allocation of the Government of Seychelles.
